Introduction

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships through options events, assemblies and group discussions and taster events.
- To understand how to make applications for the full range of academic and technical courses.

Careers Provision during Covid 19

During the Covid 19 pandemic, the careers department has the potential to be hindered through a variety of factors which could lead to students having less access to careers advice or become less focused on their future careers. In the continued effort to build a world class careers provision, it is important to proactively address where the students might have less access to careers opportunity, and proactively resolve this in order to give students the best possible advice and guidance under the current circumstances.

Risks to Careers Provision during Covid 19

- Students not having access to external speakers in school
- Students not having access to careers based trips such as, Apprenticeship fairs and Careers fairs.
- Students not being able to access employability skills
- Students being unable to take part in careers focused enrichment days.
- Students not having access to information regarding higher level apprenticeships

How BRS Will Adapt Provision 2020 2021

- Students will have access to specialist speakers through remote presentations.
- School will work with providers to re-arrange trips to later in the year, and still give access to College and careers fairs.
- Employability Skills will be run by teaching staff in school, using resources provided by expert external agencies.
- Enrichment days will run later in the year, when visitors are allowed in school, or will be run by staff.
- The Careers Advisor will send out weekly information via emails or firefly to keep students updated of career opportunities despite the limitations of Covid 19.

Premises and facilities

The school will make the main hall, classrooms or private meeting rooms available for discussions between the provider and students, as appropriate to the activity. The school will also make available any specialist equipment to support provider presentations. This will all be discussed and agreed in advance of the visit with the Careers Adviser or a member of their team.

Providers are welcome to leave a copy of their prospectus or other relevant course literature. Access to the Careers Adviser is available to all students at lunch and break times.
