

# Purpose of the policy

The centre is committed to ensuring that the exams management and administration process is run effectively and efficiently. This exam policy will ensure that:

- all aspects of the centre's exam process is documented, supporting the exams contingency plan, and other relevant exams-related policies, procedures and plans are signposted to
- all centre staff involved in the exams process clearly understand their roles and responsibilities
- all exams and assessments are conducted according to JCQ and awarding body regulations, guidance and instructions, maintaining the integrity and security of the exam/assessment system at all times
- · exam candidates understand the exams process and what is expected of them

This policy is reviewed annually to ensure ways of working in the centre are accurately reflected and that exams and assessments are conducted to current JCQ (and awarding body) regulations, instructions and guidance.

This policy will be communicated to all relevant centre staff.

Relevant policies and procedures will also be communicated to students and parents of students prior to the 2023/2024 examination period.

# Roles and responsibilities overview

The head of centre is the individual who is accountable to the awarding bodies for ensuring that the centre is always compliant with the published JCQ regulations and awarding body requirements to ensure the security and integrity of the examinations/assessments. This individual must have the authority to deploy the necessary resources to ensure that the centre is always compliant in meeting those published JCQ regulations and awarding body requirements.

Heads of centre must ensure that senior leadership teams and exam office personnel familiarise themselves with the entire contents of JCQ *General Regulations for Approved Centres* booklet. In particular, heads of centre must familiarise themselves with sections 5.1, 5.3 and 5.4.

Heads of centre must ensure that relevant members of staff respond promptly to requests for information from awarding bodies relating to the administration and conducting of examinations/assessments. (GR, section 1)

The examinations officer is the person appointed by the head of centre to act on behalf of, and be the main point of contact for, the centre in matters relating to the general administration of awarding body examinations and assessments.

### **Head of centre responsibilities:**

The head of centre is the individual who is accountable to the awarding bodies for ensuring that the centre is always compliant with the published JCQ regulations and awarding body requirements to ensure the security and integrity of the examinations/assessments.

It is the responsibility of the head of centre to ensure that all staff comply with the instructions in the (Instructions for conducting examinations) booklet. Failure to do so may constitute malpractice as defined in the JCQ publication Suspected Malpractice: Policies and Procedures, 1 September 2023 to 31 August 2024: <a href="https://www.jcq.org.uk/exams-office/malpractice">https://www.jcq.org.uk/exams-office/malpractice</a> (ICE Introduction)

### Head of centre

- Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:
  - General regulations for approved centres (GR)
  - <u>Instructions for conducting examinations</u> (ICE)
  - Access Arrangements and Reasonable Adjustments (AA)
  - Suspected Malpractice Policies and Procedures (SM)
  - <u>Instructions for conducting non-examination assessments</u> (NEA) (and the instructions for conducting coursework)
  - A guide to the special consideration process (SC)
- Ensures the centre has appropriate accommodation to support the size of the cohorts being taught including appropriate accommodation for candidates requiring access arrangements.
- If using a third part party to deliver any part of a qualification (including its assessments) at the centre:
  - maintains oversight of, and responsibility for, the delivery of the qualification in accordance with JCQ regulations and awarding body requirements
  - has in place a written agreement with the third party to ensure there is a shared understanding of the arrangement and will manage the risk of failure by the third party to deliver the expected service
  - ensures that a copy of the written agreement is available for inspection if requested by the awarding body
- Ensures that relevant members of staff respond promptly to actions raised by the JCQ Centre Inspection Service, understanding that failure to do so could result penalties (See National Centre Number Register and requirements)
- Ensures that the centre promptly reports any incidents to the relevant awarding body/bodies which might compromise any aspect of assessment delivery such as a cyber-attack
- Ensures other relevant centre staff where they may be involved in the receipt and dispatch of confidential exam materials are briefed on the requirements for maintaining the integrity and confidentiality of the exam materials
- Ensures members of centre staff do not forward emails and letters from awarding body or JCQ personnel without prior consent to third parties or upload such correspondence onto social media sites and applications
- Ensures members of centre staff do not advise parents/candidates to contact awarding bodies/JCQ directly nor provide them with addresses/email addresses of awarding body examining/assessment personnel or JCQ personnel

# Recruitment, selection and training and support

- Retains a workforce of an appropriate size and competence, including sufficient managerial and other resource, to undertake the delivery of the qualification as required by an awarding body.
   This includes taking reasonable steps to ensure occupational competence where this is required for the assessment of specific qualifications
- Provides fully qualified teachers to mark non-examination assessments, and/or fully qualified assessors for the verification of centre-assessed components

- Enables the relevant senior leader(s), the examinations officer (EO) and the SENCo to receive appropriate training and support in order to facilitate the effective delivery of examinations and assessments within the centre, and ensure compliance with the published JCQ regulations
- Appoints a SENCo who will determine appropriate arrangements for candidates with learning difficulties and disabilities
- Ensures that the SENCo has sufficient time to both manage the access arrangements process within the centre and familiarise him/herself with the JCQ publication *Access Arrangements* and *Reasonable Adjustments*
- Ensures that the examinations officer has sufficient time to perform their role and familiarise him/herself with all relevant awarding body and JCQ documentation
- Ensures that the examinations officer is line managed and actively supported by a member of the senior leadership team who has a good working knowledge of the examination system

### **External and Internal governance arrangements**

- Has in place a written escalation process should the head of centre, or a member of the senior leadership team with oversight of examination administration, be absent - Escalation Process
   Exams 2023/2024
- Has in place a member of the senior leadership team who will provide effective support and supervision of the examinations officer to ensure that the integrity and security of examinations and assessments is maintained throughout an examination series
- Ensures centre staff undertake key tasks within the exams process and meet internal deadlines set by the EO
- Can confirm to an awarding body the external governance arrangements so that the awarding body has confidence in the integrity of centre activities such as the delivery of qualifications and the conducting of exams and assessments
- Makes sure that a teacher, a teaching assistant, a tutor or a senior member of centre staff who
  teaches the subject being examined, or a Learning Support Assistant who has supported one or
  more candidates is not an invigilator during an examination

# **Delivery of qualifications**

- Delivers qualifications, as required by the awarding body, in accordance with relevant equality legislation. This includes but is not limited to ensuring that qualifications are made available to all candidates capable of undertaking them and seeking reasonable adjustments for disabled candidates
- Enables candidates to receive sufficient and up to date laboratory experience, or relevant training where required by the subject concerned

# **Public liability**

• Complies with local health and safety rules which are in place and that the centre is adequately covered for public liability claims

# **Security of assessment materials**

• Takes all reasonable steps to maintain the integrity of the examinations/assessments, including the security of all assessment materials, by ensuring:

- the location of the centre's secure storage facility in a secure room which must only be used for the purpose of administering secure examination materials
- the secure room only contains exam-related material
- there are between two and six keyholders only and that each keyholder must fully understand their responsibilities as a key holder to the secure storage facility
- access to the secure room and secure storage facility is restricted to the authorised two to six keyholders (one of whom must be the exams officer) and staff approved by the head of centre are accompanied by a keyholder at all times
- appropriate arrangements are in place to ensure that confidential examination materials are only handed over to authorised members of centre staff
- appropriate arrangements are in place for handling secure electronic materials
- the relevant awarding body is immediately informed if the security of question papers or confidential supporting instructions is put at risk
- that when it is permitted to remove question paper packets from secure storage, and to avoid potential breaches of security, arrangements are in place to carefully check and record that the correct question paper packets are opened (If it is ever subsequently identified following this check that the wrong question paper packet has been opened, it will be resealed and the incident reported to the relevant awarding body's Malpractice Investigation Team immediately)
- Makes arrangements to receive, check and store question papers and examination material safely and securely at all times and for as long as required in accordance with the current JCQ publication Instructions for conducting examinations
- Makes arrangements to receive and issue material received from the awarding bodies to staff and candidates, and notify them of any advice and instructions relevant to the examinations and assessments
- Allows candidates access to relevant pre-release materials on, or as soon as possible after, the date specified by the awarding bodies

### Malpractice

- Through taking an ethical approach and working proactively to avoid malpractice among students and staff takes all reasonable steps to prevent the occurrence of any malpractice/maladministration before, during and after assessments have taken place
- Ensures any person involved in administering, teaching or completing
   examinations/assessments is advised that where malpractice is suspected, or alleged, personal
   data about them will be provided to the awarding body (or bodies) whose
   examinations/assessments are involved. Personal data about them may also be shared with
   other awarding bodies, the qualifications regulator or professional bodies in accordance with
   the JCQ publication Suspected Malpractice Policies and Procedures
- Ensures irregularities are investigated and informs the awarding bodies immediately of any alleged, suspected or actual incidents of malpractice or maladministration, involving a candidate or a member of staff, completing the appropriate documentation
- As required by an awarding body, ensures evidence of any instances of alleged or suspected
  malpractice (which includes maladministration) is gathered in accordance with the JCQ
  publication Suspected Malpractice Policies and Procedures and provides such information and
  advice as the awarding body may reasonably require

### **Policies and Procedures**

- Ensures Malpractice Policy (Exams) 2023/2024 (GR section 5.3) is in place and available for inspection, See separate policy which now includes AI Use in Assessments: Protecting the Integrity of Qualifications (http://www.jcq.org.uk/exams-office/malpractice)
- Ensures risks to the exam process are assessed and appropriate risk management processes/contingency plans are in place (that allow the senior leadership team to act immediately in the event of an emergency or where the head of centre, the exams officer or SENCo is absent at a critical stage of the exam cycle) - Exam Contingency Plan 2023/2024
- Ensures the centre documents a separate policy for lockdown before, during or at the end of exams - Lockdown Policy Exams 2023/2024
- Ensures an internal appeals procedure is in place and drawn to the attention of candidates and (where relevant) their parents/carers Internal Appeals Procedure 2023/2024
- Ensures the centre's equalities policy demonstrating the centre's compliance with relevant legislation is in place and details the processes followed in respect of identifying the need for, requesting and implementing access arrangements Equalities Policy Exams 2023/2024
- Ensures a complaints policy covering general complaints regarding the centre's delivery or administration of a qualification is in place and drawn to the attention of candidates and their parents/carers Complaints Policy Exams 2023/2024
- Ensures the centre has a child protection/safeguarding policy in place, including Disclosure and Barring Service (DBS) clearance, which satisfies current legislative requirements - Child Protection and Safeguarding Policy Exams 2023/2024
- Ensures the centre has a data protection policy in place that complies with General Data
   Protection Regulation and Data Protection Act 2018 regulations Data Protection Policy Exams
   2023/2024
- Ensures the centre has a whistleblowing policy in place Whistleblowing Policy Exams 2023/2024
- Ensures the centre has documented processes in place relating to access arrangements and reasonable adjustments - Access Arrangements Policy 2023/2024

### **Conflicts of interest**

- Ensures the relevant awarding bodies are informed before the published deadline for entries for each examination series of any potential conflict of interest where:
  - a member of centre staff is taking a qualification at the centre which includes internally assessed components/units (noting that being entered by the centre must be a last resort where unable to find an alternative centre)
  - a candidate is being taught and prepared for a qualification which includes internally assessed components/units by a member of centre staff with a close relationship to the candidate
- Maintains clear records that confirm the measures taken/protocols in place to mitigate any potential risk to the integrity of the qualifications affected by the above, and where:
  - a member of exams office staff has a close relationship to a candidate being entered for exams and assessments at the centre or at another centre
  - a member of centre staff is taking a qualification at the centre which does not include internally assessed components/units (noting that being entered by the centre must be a last resort where unable to find an alternative centre)

- a member of centre staff is taking a qualification at another centre

### **National Centre Number Register and other information requirements**

- Provides contact details and an address to which all correspondence in connection with the administration of examinations and assessments can be directed which must be the registered address of the centre
- Ensures the National Centre Number Register annual update is responded to by the end of October every year
- Takes responsibility for confirming, on an annual basis, that they are both aware of and
  adhering to the latest version of the JCQ's regulations. This confirmation is managed as part of
  the National Centre Number Register (NCNR) annual update by completion of the Head of
  Centre Declaration
- Understands that this responsibility cannot be delegated to a member of the senior leadership team or the examinations officer, and acknowledges that failure to respond to the NCNR annual update, and/or the head of centre's declaration, will result in:
  - the centre status being suspended
  - the centre not being able to submit examination entries
  - the centre not receiving or being able to access question papers and ultimately, awarding bodies could withdraw their approval of the centre

# **Centre inspections**

- Co-operates with the JCQ Centre Inspection Service, an awarding body or a regulatory authority
  when subject to an inspection, an investigation or an unannounced visit, and takes all reasonable
  steps to comply with all requests for information or documentation made by an awarding body
  or regulatory authority as soon as is practical
- Allows all venues used for examinations and assessments, paperwork and secure storage facilities to be open to inspection
- Understands the JCQ Centre Inspector will identify him/herself with a photo ID card and must be accompanied throughout his/her tour of the premises, including inspection of the centre's secure storage facility

### **Exams officer**

Understands the contents of annually updated JCQ publications including:

General regulations for approved centres

Instructions for conducting examinations

<u>Suspected Malpractice – Policies and Procedures</u>

Post-Results Services (PRS)

A guide to the special consideration process

- Completes/submits the National Centre Number Register annual update (administered on behalf
  of the JCQ member awarding bodies by OCR https://ocr.org.uk/administration/ncn-annualupdate/) by the end of October every year
  - Confirms the details or informs the awarding bodies of any changes to the centre's contact details through the National Centre Number Register
  - Informs the National Centre Number Register Team immediately (e-mail address ncn@ocr.org.uk) if any changes occur after the National Centre Number Register annual update has taken place

- Where applicable, informs the National Centre Number Register Team no later than 6 weeks prior to moving to a new address or a re-location of the secure storage facility
- Informs the National Centre Number Register Team immediately of any other changes in circumstances that could affect the centre's status
- Is familiar with the contents of annually updated information from awarding bodies on administrative procedures, key tasks, key dates and deadlines
- Ensures key tasks are undertaken and key dates and deadlines met
- Recruits, trains and deploys a team of internal/external invigilators as required and keeps a record of the content of training provided to invigilators for the required period
- Works with the SENCo to ensure invigilators supervising access arrangement candidates and those acting as a facilitator supporting access arrangement candidates fully understand the respective role and what is and what is not permissible in the exam room
- Supports the head of centre in ensuring that awarding bodies are informed (where required) of any declaration/conflict of interest involving candidates and relevant members of centre staff before the published deadline for entries for each examination series
- Briefs other relevant centre staff where they may be involved in the receipt and dispatch of confidential exam materials on the requirements for maintaining the integrity and confidentiality of the exam materials

# Senior leaders (SLT)

 Are familiar with the contents, refer to and direct relevant centre staff to annually updated JCQ publications including:

General regulations for approved centres

<u>Instructions for conducting examinations</u>

Access Arrangements and Reasonable Adjustments

<u>Suspected Malpractice – Policies and Procedures</u>

<u>Instructions for conducting non-examination assessments</u> (and the instructions for conducting coursework)

A guide to the special consideration process

- Ensure teaching staff undertake key tasks, as detailed in this policy, within the exams process (exam cycle) and meet internal deadlines set by the EO and SENCo
- Ensure teaching staff keep themselves updated with awarding body subject and teacherspecific information to confirm effective delivery of qualifications
- Ensure teaching staff attend relevant awarding body training and update events

# Special educational needs co-ordinator (SENCo)

 Understands the contents, refers to and directs relevant centre staff to annually updated JCQ publications including:

Access Arrangements and Reasonable Adjustments

• Leads on the access arrangements and reasonable adjustments process (referred to in this policy as 'access arrangements')

- If not the qualified access arrangements assessor, works with the person appointed, on all matters relating to assessing candidates and ensures the correct procedures are followed
- Presents when requested by a JCQ Centre Inspector, evidence of the assessor's qualification

# **Teaching staff**

- Undertake key tasks, as detailed in this policy, within the exams process and meet internal deadlines set by the EO and SENCo
- Keep updated with awarding body subject and teacher-specific information to confirm effective delivery of qualifications
- Attend relevant awarding body training and update events

# **Invigilators**

- Attend training on the current regulations, updates, briefing and review sessions as required
- Provide information as requested on their availability to invigilate
- Sign a confidentiality and security agreement and confirm whether they have any current maladministration/malpractice sanctions applied to them

# **Reception staff**

• Support the EO in the receipt and dispatch of confidential exam materials and follow the requirements for maintaining the integrity and confidentiality of the exam materials

### Site staff

Support the EO in relevant matters relating to exam rooms and resources

### **Candidates**

 Where applicable in this policy, the term 'candidates' refers to candidates and/or their parents/carers.

# The exam cycle

The exams management and administration process that needs to be undertaken for each **exam series** is often referred to as the **exam cycle** and relevant tasks required within this grouped into the following stages:

- planning
- entries
- pre-exams
- exam time
- results and post-results

This policy identifies roles and responsibilities of centre staff within this cycle.

### Planning: roles and responsibilities

# Information sharing

### Head of centre

Directs relevant centre staff to annually updated JCQ publications including <u>GR</u>, <u>ICE</u>, <u>AA</u>, <u>SM</u> and <u>NEA</u> (and the instructions for conducting coursework) and <u>SC</u>

### **Exams officer**

- Signposts relevant centre staff to JCQ publications and awarding body documentation relating to the exams process that has been updated
- Signposts relevant centre staff to JCQ information that should be provided to candidates
- As the centre administrator, approves relevant access rights for centre staff to access awarding body secure extranet sites

# Information gathering

### **Exams officer**

- Undertakes an annual information gathering exercise in preparation for each new academic year to ensure data about all qualifications being delivered is up to date and correct
- Collates all information gathered into one central point of reference
- Researches awarding body guidance to identify administrative processes, key tasks, key dates and deadlines for all relevant qualifications
- Produces an annual exams plan of key tasks and key dates to ensure all external deadlines can be effectively met; informs key centre staff of internal deadlines
- Collects information on internal exams to enable preparation for and conduct of domestic exams within the centre

### **Senior Leaders**

- Respond (or ensures teaching staff respond) to requests from the EO on information gathering
- Meet the internal deadline for the return of information
- Inform the EO of any changes to information in a timely manner minimising the risk of late or other penalty fees being incurred by an awarding body
- Note the internal deadlines in the annual exams plan and directs teaching staff to meet these

### **Access arrangements**

### **Head of centre**

- Ensures there is appropriate accommodation for candidates requiring access arrangements in the centre for all examinations and assessments
- Ensures a written process is in place to not only check the qualification(s) of the appointed assessor(s) but that the correct procedures are followed as in Chapter 7 of the JCQ publication Access Arrangements and Reasonable Adjustments
- Ensures the SENCo is fully supported in effectively implementing access arrangements and reasonable adjustments once approved

### **SENCo**

- Assesses candidates (or works with the appropriately qualified assessor as appointed by the head of centre) to identify access arrangements/reasonable adjustments requirements
- Gathers evidence to support the need for access arrangements for a candidate
- Liaises with teaching staff to gather evidence of normal way of working of an affected candidate
- Determines candidate eligibility for arrangements or adjustments that are centre-delegated
- Gathers signed Personal data consent forms from candidates where required and ensures Data Protection Confirmations by the SENCo are completed
- Applies for approval through Access arrangements online (AAO) via the Centre Admin Portal (CAP), where required or through the awarding body where qualifications sit outside the scope of AAO
- Keeps a file for each candidate for JCQ inspection purposes containing all the required documentation (if documentation is stored electronically, an e-folder must be created for each individual candidate which must hold each of the required documents for inspection)
- Employs good practice in relation to the Equality Act 2010
- Liaises with the EO regarding exam time arrangements for access arrangement candidates
- Ensures staff appointed to facilitate access arrangements for candidates are thoroughly trained and understand the rules of the particular arrangement(s) and keeps a record of the content of training provided to facilitators for the required period
- Works with the EO to ensure invigilators and those acting as a facilitator fully understand the respective role and what is and what is not permissible in the exam room
- Liaises with the relevant member(s) of the senior leadership team regarding the centre's policy
  on the use of word processors in examinations Word processor Policy Exams 2023/2024
- Ensures criteria for candidates granted alternative rooming arrangements is clear, meets JCQ regulations and best meets the needs of individual candidates and remaining candidates in main exam rooms

# **Alternative Rooming Policy**

See AA (sections 4.2, 5.16) and ICE (section 14.18)

In certain circumstances a candidate with "an established difficulty" may be eligible to take exams in alternative rooming arrangements. Centres may also receive requests from candidates (and/or parents/carers) to take their exams in alternative rooms.

### The SENCo will ensure

- the criteria for candidates granted alternative rooming arrangements are clear and complies with JCQ regulations
- that the proposed access arrangement does not disadvantage or advantage the candidate (AA 4.2.1)
- that this is the candidate's normal way of working in the centre for internal tests and mock examinations (AA 5.16)

It must be noted that nervousness, low level anxiety or being worried about examinations is not sufficient grounds for separate invigilation within the centre.

# Senior leaders, Teaching staff

- Support the SENCo in determining and implementing appropriate access arrangements/reasonable adjustments
- Provide a **word processor policy** for the centre which details the criteria the centre uses to award and allocate word processors for examinations and ensures it is available for inspection.

### Internal assessment and endorsements

### Head of centre

### Controlled assessments, coursework and non-examination assessments

- Ensures appropriate controls are in place which allow accurate data to be submitted to the awarding bodies (e.g. internally assessed marks)
- Ensures arrangements are in place to co-ordinate and standardise all marking of centre- assessed
  components and ensures that candidates' centre-assessed work is produced, authenticated and
  marked, or assessed and quality assured in accordance with the awarding bodies' instructions
  (including where relevant, private candidates)
- Ensures that teaching staff, in accordance with awarding bodies' instructions, return all subjectspecific forms by the required date
- Provides fully qualified teachers to mark non-examination assessments and/or fully qualified assessors for the verification of centre-assessed components
- Ensures an internal appeals procedure relating to internal assessment decisions is in place for a candidate to appeal against and request a review of the centre's marking (see Roles and responsibilities overview)
- Ensures a non-examination assessment policy is in place for qualifications which include components of non-examination assessment (controlled assessment policy) - Non-Examination Assessment Policy 2023/2024
- Ensures any irregularities relating to the production of work by candidates are investigated and dealt with internally if discovered prior to a candidate signing the authentication statement (where required) or reported to the awarding body if a candidate has signed the authentication statement

### **Senior leaders**

- Ensure teaching staff have the necessary and appropriate knowledge, understanding, skills, and training to set tasks, conduct task taking, and to assess, mark and authenticate candidates' work (including where relevant, private candidates)
- Ensure appropriate internal moderation, standardisation and verification processes are in place
- Ensure teaching staff delivering qualifications which include elements of coursework follow JCQ
   Instructions for conducting coursework and the specification provided by the awarding body
- Ensure teaching staff delivering specifications (which include components of non-examination assessment) follow JCQ <u>Instructions for conducting non-examination assessments</u> and the specification provided by the awarding body
- Ensure teaching staff inform candidates of their centre assessed marks as a candidate may request a review of the centre's marking before marks are submitted to the awarding body

### **Teaching staff**

- Ensure appropriate instructions for conducting internal assessment are followed
- Ensure candidates are aware of JCQ and awarding body information for candidates on producing work that is internally assessed (coursework, non-examination assessments, social media) prior to assessments taking place
- Ensure candidates are informed of their centre assessed marks as a candidate may request a review of the centre's marking before marks are submitted to the awarding body

### **Exams officer**

- Identifies relevant key dates and administrative processes that need to be followed in relation to internal assessment
- Signposts teaching staff to relevant JCQ *information for candidates* documents that are annually updated

### **Invigilation**

### **Head of centre**

- Ensures relevant support is provided to the EO in recruiting, training and deploying a team of invigilators
- Ensures, if contracting supply staff to act as invigilators, that such persons are competent and fully trained, understanding what is and what is not permissible (and not taking on its own an assurance from a recruitment agency, that this is the case)
- Determines if additional invigilators will be deployed in timed Art exams in addition to the subject teacher to ensure the supervision of candidates is maintained at all times

### **Exams officer**

- Recruits additional invigilators where required to effectively cover all exam periods/series throughout the academic year
- Collects information on new recruits to identify if they have invigilated previously and if any current maladministration/malpractice sanctions are applied to them
- Provides a training event for new invigilators on the instructions for conducting exams and an annual update event for the existing invigilation team so that they are aware of any changes in a new academic year before they are allocated to invigilate an exam
- Ensures invigilators supervising access arrangement candidates understand their role (and the role of a facilitator who may be supporting a candidate) and the rules and regulations of the access arrangement(s)
- Ensures invigilators are briefed on the access arrangement candidates in their exam room and made aware of the access arrangement(s) awarded (ensuring that these candidates are identified on the seating plan) and confirms invigilators understand what is and what is not permissible
- Collects evaluation of training to inform future events

### **Entries: roles and responsibilities**

### **Estimated entries**

### **Exams officer**

- Requests estimated or early entry information, where this may be required by awarding bodies, from Heads of Department in a timely manner to ensure awarding body external deadlines for submission can be met
- Makes candidates aware of the JCQ Information for candidates Privacy Notice at the start of
  a vocational qualification or when entries are being processed for a general qualification

### **Senior Leaders**

- Provides information requested by the EO to the internal deadline
- Informs the EO immediately of any subsequent changes to information

### **Final entries**

### **Head of Centre**

• Ensures appropriate controls are in place which allow accurate data to be submitted to the awarding bodies (e.g. entries)

### **Exams officer**

- Requests final entry information from HoDs in a timely manner to ensure awarding body external deadlines for submission can be met
- Informs HoDs of subsequent deadlines for making changes to final entry information without charge
- Confirms with HoDs final entry information that has been submitted to awarding bodies
- Ensures as far as possible that entry processes minimise the risk of entries or registrations being missed reducing the potential for late or other penalty fees being charged by awarding bodies
- Observes each awarding body's terms and conditions for the entry and withdrawal of candidates for their examinations and assessments, and observes any regulatory requirements for the qualification

### **Senior Leaders**

- Provide information requested by the EO to the internal deadline
- Informs the EO immediately, or at the very least prior to the deadlines, of any subsequent changes to final entry information, which includes:
  - changes to candidate personal details
  - amendments to existing entries
  - withdrawals of existing entries
- Checks final entry submission information provided by the EO and confirms information is correct

### **Exams officer**

Has clear entry procedures in place to minimise the risk of late entries

### **Senior leaders**

- Minimise the risk of late entries by
  - following procedures identified by the EO in relation to making final entries on time
  - meeting internal deadlines identified by the EO for making final entries

### **Re-sit entries and Private candidates**

Students must pay for re-sit entries. The centre will refund these fees following results, provided that the grade has increased by a full grade.

If applicable, any private candidates will be charged for entries made although currently BRS is not on the private candidates register.

# **Candidate statements of entry**

### **Exams officer**

Provides candidates with statements of entry for checking

# **Teaching staff**

 Ensure candidates check statements of entry and return any relevant confirmation required to the EO

### **Candidates**

Confirm entry information is correct or notify the EO of any discrepancies

# **Pre-exams: roles and responsibilities**

# Access arrangements and reasonable adjustments

### **SENCo**

- Ensures appropriate arrangements, adjustments and adaptations are in place to facilitate access to exams/assessments for candidates where they are disabled within the meaning of the Equality Act (unless a temporary emergency arrangement is required at the time of an exam)
- Ensures a candidate is involved in any decisions about arrangements, adjustments and /or adaptations that may be put in place for him/her
- Ensures exam information (JCQ information for candidates documents, individual exam timetable etc.) is adapted where this may be required for a disabled candidate to access it
- Allocates appropriately trained centre staff to facilitate access arrangements for candidates in exams and assessments (ensuring that the facilitator appointed meets JCQ requirements and fully understands the rules of the access arrangement)
- Where relevant, ensures the necessary and appropriate steps are undertaken to gather an
  appropriate picture of need and demonstrate normal way of working for a private candidate
  (including distance learners and home educated candidates) and that the candidate is assessed
  by the centre's appointed assessor

# **Briefing candidates**

### **Exams officer**

- Issues individual exam timetable information to candidates and informs candidates of any designated contingency sessions awarding bodies may identify in the event of national or significant local disruption to exams
- Prior to exams issues relevant JCQ information for candidates documents
- Where relevant, issues relevant awarding body information to candidates
- Issues centre exam information to candidates including information on:
  - exam timetable clashes
  - arriving late for an exam
  - absence or illness during exams
  - what equipment is/is not provided by the centre
  - food and drink in exam rooms
  - unathorised items in exam rooms
  - when and how results will be issued and the staff that will be available
  - post-results services information and how the centre will deal with requests from candidates
  - when and how certificates will be issued

# Access to scripts, reviews of results and appeals procedures

# **Exams officer/SLT**

- The Exams Officer and Senior members of centre staff will be accessible to candidates immediately after the publication of results so that results may be discussed and decisions made on the submission of enquiries.
- Candidates will be informed on results day of the arrangements for post-results services, including access to scripts, clerical re-checks, reviews of marking, reviews of moderation and appeals to the awarding bodies and will be advised
  - how to request a service
  - deadlines that have to be met
  - any associated fees
  - how they are informed of the outcome of the request
  - the internal appeals procedure to manage disputes where a candidate disagrees with a centre decision not to support a review of results or an appeal see separate Internal Appeals Procedure 2023/2024 and Complaints Policy Exams 2023/2024

# Procedure for dealing with requests for access to scripts, clerical re-checks, reviews of marking:

 Candidates must provide their written consent for clerical re-checks, reviews of marking and access to scripts services offered by the awarding bodies after the publication of results (GR 5.13). The appropriate paperwork will be available on

- results day. Once results day is over, informed consent via candidate email is acceptable.
- Candidates will be made aware that the final subject grade and/or mark awarded following a clerical re-check or a review of marking, and any subsequent appeal, may be lower than, higher than, or the same result which was originally awarded.
- Consent can only be collected from a candidate after the publication of results
- The centre will retain consent forms from candidates for at least six months following the outcome of a clerical re-check, review of marking, any subsequent appeal and also consent forms for the use of scripts.
- Electronic requests for clerical re-checks, reviews of marking and access to scripts will be actioned within the published deadlines in accordance with the JCQ publication Post-results services (GR 5.13)
- The Exams Officer will ensure outcomes of clerical, re-checks, reviews of marking, reviews of moderation and appeals are made known to candidates as soon as possible (GR 5.13)

# **Dispatch of exam scripts**

### **Exams officer**

 Identifies and confirms arrangements for the dispatch of candidate exam scripts with the DfE (STA) 'yellow label service' or the awarding body where qualifications sit outside the scope of the service

### **Estimated grades**

### **Senior leaders**

• Ensure teaching staff provide estimated grade information to the EO by the internal deadline (where this still may be required by the awarding body)

### **Exams officer**

- Submits estimated grade information to awarding bodies to meet the external deadline (where this may still be required by the awarding body)
- Keeps a record to track what has been sent

### Internal assessment and endorsements

### **Head of centre**

 Ensures procedures are in place for candidates to appeal internal assessment decisions and make requests for reviews of marking

### **SENCo**

• Liaises with teaching staff to implement appropriate access arrangements for candidates undertaking internal assessments and practical endorsements

# **Teaching staff**

- Support the SENCo in implementing appropriate access arrangements for candidates undertaking internal assessments and practical endorsements
- Assess and authenticate candidates' work
- Assess endorsed components
- Ensure candidates are informed of centre assessed marks prior to marks being submitted to awarding bodies

### **Senior leaders**

- Ensure teaching staff assess and authenticate candidates' work to the awarding body requirements
- · Ensure teaching staff assess endorsed components according to awarding body requirements
- Ensure teaching staff provide marks for internally assessed components and grades for endorsements of qualifications to the EO to the internal deadline
- Ensure teaching staff provide required samples of work for moderation and sample recordings for monitoring to the EO to the internal deadline

### **Exams officer**

- Submits marks, endorsement grades and samples to awarding bodies/moderators/monitors to meet the external deadline

### **Exams officer**

- Provides an annually reviewed/updated invigilator handbook to invigilators, trains new invigilators on the current regulations on appointment and updates experienced invigilators of any regulation changes and any changes to centre-specific processes
- Deploys invigilators effectively to exam rooms throughout an exam series (including the
  provision of a roving invigilator where a candidate and invigilator are accommodated on a 1:1
  basis to enter the room at regular intervals in order to observe the conducting of the exam,
  ensure all relevant rules are being adhered to and to support the practical assistant/reader
  and/or scribe in maintaining the integrity of the exam)
- Allocates invigilators to exam rooms (or where supervising candidates due to a timetable clash) according to the required ratios
- Liaises with the SENCo regarding the facilitation and invigilation of access arrangement candidates

### **SENCo**

Liaises with the EO regarding facilitation and invigilation of access arrangement candidates

### **Invigilators**

Provide information as requested on their availability to invigilate throughout an exam series

# **JCQ Centre Inspections**

### **Exams officer or Senior leader**

Will accompany the Inspector throughout the visit

# **SENCo** or relevant **Senior leader** (in the absence of the SENCo)

- Will meet with the inspector when requested to provide documentary evidence regarding access arrangement candidates and address any questions, the inspector may raise
- Ensures that information is readily available for inspection at the venue where the candidate is taking the exam(s)

# Seating and identifying candidates in exam rooms

### **Exams officer**

Ensures a procedure is in place to verify candidate identity including private candidates

### **Candidate Identification Procedure**

- The Invigilators will call candidates in by their seat number according to the seating plan
- Photo cards showing the candidate, their name and exam number will already be placed on the correct desk according to the seating plan
- A member of SLT will always be in the exam room to assist the invigilators in identifying pupils
- Any external candidate who is not known to the school must show documentary evidence e.g. passport or driving licence to prove that they are the person registered for the exam
- Where it is impossible to identify a candidate due to the wearing of religious clothing, e.g. a veil, the candidate will be approached by a member of SLT of the same gender and taken to a private room where they will be politely asked to remove the religious clothing for identification purposes. Once identification has been established the candidate can replace any garments and proceed to the exam room. The candidate will have been informed of this procedure well before the examination series begins
- Once candidates are seated and have started the examination the invigilators can inform the Exams Officer of the identification of absent candidates who can be contacted as to their whereabouts
- Ensures invigilators are aware of the procedure

Provides seating plans for exam rooms according to JCQ and awarding body requirements (and
ensures candidates with access arrangements are identified on the seating plan) and
invigilators are informed of those candidates with access arrangements and made area of the
access arrangement(s) awarded.

# **Invigilators**

- Follow the procedure for verifying candidate identity provided by the EO
- Seat candidates in exam rooms as instructed by the EO/on the seating plan

# **Security of exam materials**

### **Exams officer**

- Confirms appropriate arrangements are in place to ensure that confidential materials are only handed over to those authorised by the head of centre
- Ensures access to the secure room is restricted and staff approved by the head of centre are accompanied by a keyholder at all times. There are only two keyholders, both of whom fully understand their responsibilities as a key holder to the secure storage facility
- Has a process in place to demonstrate the receipt, secure movement and secure storage of confidential exam materials within the centre
- Ensures a log is kept at the initial point of delivery recording confidential materials received and signed for by authorised staff within the centre and that appropriate arrangements are in place for confidential materials to be immediately transferred to the secure storage facility until they can be removed from the dispatch packaging and checked in the secure room before being returned to the secure storage facility in timetable order
- Carefully checks question paper packets when they are removed from the dispatch packing and keeps a log of the check
- Ensures the secure storage facility contains only current and live confidential material (ensuring that past examination question papers, internal tests and mock examinations are not kept in the centre's secure storage facility)
- Ensures that examination stationery, including answer booklets and formula booklets, are stored in the secure room (attempting to store this material in the secure storage facility, when sufficient space allows)
  - Ensures the integrity and security of any electronic question paper is maintained during the downloading, printing and collating process (ensuring printing is carried out in a secure environment to prevent unauthorised personnel accessing live assessment materials and ensuring only authorised members of centre staff have access to electronic question papers) At least two and no more than six members of centre staff should be authorised to handle secure electronic materials, one of whom must be the exams officer\*. Other members of centre staff may assist with printing and collation provided they are under supervision.
  - \*For AQA examinations, one member of centre staff can be authorised to handle secure electronic material.

# **Reception staff**

 Follow the process to log confidential materials delivered to/received by the centre to the point materials are issued to authorised staff for placing in the secure storage facility

### **Teaching staff**

 Adhere to the process to record the secure movement of confidential materials taken from or returned to secure storage throughout the time the material is confidential

# **Timetabling and rooming**

### **Exams officer**

- Produces a master centre exam timetable for each exam series
- Identifies and resolves candidate exam timetable clashes according to the regulations (only applying overnight supervision arrangements in rare and exceptional circumstances and as a last resort) see ICE (section 8)
- Identifies exam rooms and specialist equipment requirements
- Allocates invigilators to exam rooms (or where supervising candidates due to an exam timetable clash) according to required ratios
- Liaises with site staff to ensure exam rooms are set up according to JCQ and awarding body requirements
- Liaises with the SENCo regarding rooming of access arrangement candidates

### **SENCo**

- Liaises with the EO regarding rooming of access arrangement candidates
- Liaises with other relevant centre staff to ensure appropriate arrangements, adjustments and adaptations are in place to facilitate access for disabled candidates to exams

### Site staff

 Liaise with the EO to ensure exam rooms are set up according to JCQ and awarding body requirements

# **Alternative site arrangements**

### **Exams officer**

- If applicable, ensures question papers will only be taken to an alternative site where the published criteria for an alternative site arrangement has been met
- Will inform the JCQ Centre Inspection Service by submitting a JCQ Alternative Site arrangement
  notification through CAP (or through the awarding body where a qualification may sit outside
  the scope of CAP) of any alternative sites that will be used to conduct timetabled examination
  components of the qualifications listed in the JCQ regulations

# **Centre consortium arrangements**

### **Exams officer**

If/where applicable, processes applications for Centre Consortium arrangements through CAP
to the awarding body deadline (or through the awarding body where a qualification may sit
outside the scope of CAP)

### Senior leaders

• If applicable, informs the EO of any joint teaching arrangements in place and where the centre is acting as the consortium co-ordinator

# **Transferred candidate arrangements**

### **Exams officer**

- If applicable, liaises with the host or entering centre, as required
- Processes requests for Transferred Candidate arrangements through CAP to the awarding body deadline (or through the awarding body where a qualification may sit outside the scope of CAP)
- Where relevant (for an internal candidate) informs the candidate of the arrangements that have been made for their transferred candidate arrangements

### **Internal exams**

### **Exams officer**

- Prepares for the conduct of internal exams under external conditions
- Provides a centre exam timetable of subjects and rooms
- Provides seating plans for exam rooms
- Requests internal exam papers from teaching staff
- Arranges invigilation where applicable to the centre

### **SENCo**

 Liaises with teaching staff to make appropriate arrangements for access arrangement candidates

# **Teaching staff**

- Provide exam papers and materials to the EO
- Support the SENCo in making appropriate arrangements for access arrangement candidates

# **Exam time: roles and responsibilities**

### **Access arrangements**

# **Exams officer**

- Provides cover sheets for access arrangement candidates' scripts where required for particular arrangements
- Has a process in place to deal with emergency/temporary access arrangements as they arise at the time of exams (applies through AAO where required or through the awarding body where qualifications sit outside the scope of AAO)

# **Candidate absence**

# Candidate absence policy

In case of candidate absence, the Exams Officer and SLT will follow up candidates and will deal with any persistent absentees. Candidates are informed before exams that they will be re-charged entry fees for unauthorised absence from exams.

### **Invigilators**

- Are informed of the policy/process for dealing with absent candidates through training
- Ensure that confirmed absent candidates are clearly marked as such on the attendance register and seating plan

### **Candidates**

• Are re-charged relevant entry fees for unauthorised absence from exams

### **Candidate behaviour**

See Irregularities below.

# **Candidate belongings**

See Unauthorised materials below.

# **Candidate late arrival**

### **Exams officer**

- Ensures that candidates who arrive very late for an exam are reported to the awarding body by submitting a report on candidate admitted very late to examination room through CAP to timescale
- Warns candidates that their work may not be accepted by the awarding body

### **Invigilators**

- Are informed of the policy/process for dealing with late/very late arrival candidates through training
- Ensure that relevant information is recorded on the exam room incident log

# Candidate late arrival policy

Late arrivals and very late arrivals will be dealt with at the discretion of the Exams Officer and SLT. Provided that adequate supervision has taken place, the candidate may be allowed into the exam room and given the opportunity to sit the examination for its published duration. The Exams Officer will accompany the candidate and give any instructions required and ensure the time is noted on the exam room incident log by the invigilator.

# **Conducting exams**

### Head of centre

• Ensures venues used for conducting exams meet the requirements of JCQ and awarding bodies

### **Exams officer**

- Ensures exams are conducted according to JCQ and awarding body instructions
- Uses an exam day checklist to ensure each exam session is fully prepared for, unplanned events can be dealt with and associated follow-up is completed

# Dispatch of exam scripts

### **Exams officer**

- Dispatches scripts as instructed by JCQ and awarding bodies
- Keeps appropriate records to track dispatch

# **Exam papers and materials**

### **Exams officer**

- Organises exam question papers and associated confidential resources in date order in the secure storage facility
- Attaches erratum notices received to relevant sealed question paper packets
- Collates attendance registers and examiner details in date order
- Regularly checks mail for updates from awarding bodies
- In order to avoid potential breaches of security, ensures care is taken to ensure the correct
  question paper packets are opened by ensuring a member of centre staff, additional to the
  person removing the papers from secure storage, e.g. a lead invigilator, checks the day, date,
  time, subject, unit/component and tier of entry if appropriate, immediately before a question
  paper packet is opened and ensures the Second Pair of Eyes sign-off sheet is correctly
  completed and recorded.
- Where allowed by the awarding body, only releases exam papers and materials to teaching departments for teaching and learning purposes after the published finishing time of the exam, or until any timetable clash candidates have completed the exam.

### Exam rooms

### Head of centre

- Ensures that internal tests, mock exams, revision or coaching sessions are not conducted in a room designated as an exam room
- Ensures that when a room is designated as an exam room it is not used for any purpose other than conducting external exams
- Ensures only authorised centre staff (who have not taught the subject being examined) are present in exam rooms to perform permitted tasks
- Ensures the centre's policy on candidates leaving the exam room temporarily is clearly communicated to candidates

# Food and drink in exam rooms/Leaving the exam room temporarily

No food items or chewing gum are allowed in the exam room. Candidates may bring a drink with them into the exam room. However, no more than 750ml of still water may be brought in a sports cap clear bottle with no label. No fizzy drinks, cans or pouches will be allowed due to the risk of spillage. Drinking too much may cause an issue since candidates will not be allowed to use the toilet facilities during exams due to issues of supervision. (ICE Section 18)

### **Exams officer**

- Ensures exam rooms are set up and conducted as required in the regulations
- Provides invigilators with appropriate resources to effectively conduct exams
- Briefs invigilators on exams to be conducted on a session by session basis (including the arrangements in place for any transferred candidates and access arrangement candidates)
- Ensures sole invigilators have an appropriate means of summoning assistance (if this is a mobile phone, instructs the invigilator that this mobile phone is only allowed to be used for this specific purpose and that it must be kept on silent mode)
- Ensures invigilators understand they must be vigilant and remain aware of incidents or emerging situations, looking out for malpractice or candidates who may be in distress, recording any incidents or issues on the exam room incident log
- Ensures invigilators understand how to deal with candidates who may need to leave the exam room temporarily in case of emergency only, recording any incidents or issues on the exam room incident log
- Provides authorised exam materials which candidates are not expected to provide themselves
- Ensures invigilators and candidates are aware of the emergency evacuation procedure
- Ensures invigilators are aware of arrangements in place for a candidate with a disability who
  may need assistance if an exam room is evacuated

### **Senior leaders**

- Ensure a documented emergency evacuation procedure for exam rooms is in place
- Ensure arrangements are in place for a candidate with a disability who may need assistance if an exam room is evacuated:

See separate policy - Emergency Evacuation Policy Exams 2023/2024

### Site staff

- Ensure exam rooms are available and set up as requested by the Exams Officer
- Ensure grounds or centre maintenance work does not disturb exam candidates in exam rooms
- Ensure fire alarm testing does not take place during exam sessions

### **Invigilators**

 Conduct exams in every exam room according to JCQ Instructions for Conducting Examinations and/or awarding body requirements as instructed in training/update events and briefing sessions

### **Candidates**

- Are required to follow the instructions given to them in exam rooms by authorised centre staff and invigilators
- Are required to remain in the exam room for the full duration of the exam

# **Irregularities/Malpractice**

### Head of centre

- Ensures (as required by an awarding body) any cases of alleged, suspected or actual incidents
  of malpractice or maladministration before, during or after examinations/assessments (by
  centre staff, candidates, invigilators) are investigated and reported to the awarding body
  immediately, by completing the appropriate documentation
- See separate policy Malpractice Policy Exams 2023/2024

### **Senior leaders**

- Ensure support is provided for the Exams Officer and invigilators when dealing with disruptive candidates in exam rooms
- Ensure that internal disciplinary procedures relating to candidate behaviour are instigated, when appropriate

### **Exams officer**

- Provides an exam room incident log in all exam rooms for recording any incidents or irregularities
- Actions any required follow-up and reports to awarding bodies as soon as practically possible after the exam has taken place

### **Invigilators**

 Record any incidents or irregularities on the exam room incident log (for example, late/very late arrival, candidate or centre staff suspected malpractice, candidate illness, disruption or disturbance in the exam room, emergency evacuation)

# **Special consideration**

### **Senior Leaders**

 Provides signed evidence on headed paper to support eligible applications for special consideration (signed by the Head of Centre)

### **Exams officer**

- Processes eligible applications for special consideration to awarding bodies
- Gathers evidence which may need to be provided by other staff in centre or candidates
- Submits requests to awarding bodies to the external deadline

### **Candidates**

Provide appropriate evidence to support special consideration applications, where required

### **Unauthorised items**

### Arrangements for unauthorised items taken into the exam room

In the examination room candidates must not have access to items other than those stated in the instructions on the question paper, the stationery list or the specification for that subject. Any unauthorised materials will be removed and can be collected from the Exams Office following the completion of the examination.

# **Invigilators**

Are informed of the arrangements through training

### **Internal exams**

### **Exams officer**

- Briefs invigilators on conducting internal exams
- Returns candidate scripts to teaching staff for marking

# **Invigilators**

Conduct internal exams as briefed by the Exams Officer

# Results and post-results: roles and responsibilities

### **Internal assessment**

### **Senior Leaders**

- Ensure teaching staff keep candidates' work, whether part of the moderation sample or not, secure and for the required period stated by JCQ and awarding bodies
- Ensure work is returned to candidates after the retention period or disposed of according to the requirements

# Managing results day(s)

### **Senior leaders**

- Identify centre staff who will be involved in the main summer results day(s) and their role
- Ensure senior members of staff are accessible to candidates immediately after the publication
  of results so that results may be discussed and decisions made on the submission of any
  requests for post-results services and ensures candidates are informed of the periods during
  which centre staff will be available so that they may plan accordingly

### **Exams officer**

 Works with senior leaders to ensure procedures for managing the main summer results day(s) are in place

### Site staff

• Ensure the centre is open and accessible to centre staff and candidates, as required for the collection of results

### **Accessing results**

### Head of centre

- Ensures results are kept entirely confidential and restricted to key members of staff until the
  official dates and times of release of results to candidates
- Understands that it is not permitted to withhold provisional results from candidates under any circumstances

### **Exams officer**

- Informs candidates in advance of when and how results will be released to them for each exam series
- Accesses results from awarding bodies under restricted release of results, where this is provided by the awarding body
- Resolves any missing or incomplete results with awarding bodies
- Issues statements of results to candidates on issue of results date
- Provides summaries of results for relevant centre staff on issue of results date

### **Post-results services**

### Head of centre

- Ensures an internal appeals procedure is available where candidates disagree with any centre
  decision not to support a clerical check, a review of marking, a review of moderation or an
  appeal
- Ensures that senior members of centre staff are available immediately after the publication of results
- Understands that if the centre has concerns about one of its components/subject cohorts, then
  requests for reviews of marking should be submitted for all candidate believed to be affected
  (candidate consent is required as marks and subject grades may be lowered, confirmed or
  raised)

### **Exams officer**

- Provides information to candidates and staff on the services provided by awarding bodies and the fees charged, ensuring that candidates understand that a review of marking can result in grades being lowered (see above regarding Briefing Candidates, Access to Scripts, Reviews of Results and Appeals Procedures)
- Publishes internal deadlines for requesting the services to ensure the external deadlines can be effectively met
- Provides a process to record requests for services and to collect candidate informed consent (after the publication of results) and fees where relevant
- Submits requests to awarding bodies to meet the external deadline
- Tracks requests to conclusion and informs candidates and relevant centre staff of outcomes
- Updates centre results information, where applicable

### **Teaching staff**

- Meet internal deadlines to request the services and gain relevant candidate informed consent
- Identify the budget to which fees should be charged

### **Candidates**

- Meet internal deadlines to request the services
- Provide informed consent and fees, where relevant

### **Analysis of results**

### **Exams and Data Manager**

- Provides analysis of results to appropriate centre staff
- Provides results information to external organisations where required
- Undertakes the DfE School and College Checking Exercises (where applicable to the centre) https://tableschecking.education.gov.uk

### **Certificates**

Certificates are provided to centres by awarding bodies after results have been confirmed.

# **Certificates Issue Procedure and Retention Policy**

Candidates are informed on results day of the date from which certificates can be collected and the collection procedure. Certificates must be collected in person and signed for and candidates must be able to produce proof of identity if required. A relative of a candidate may collect certificates on the candidate's behalf but the candidate must inform the Exams Officer beforehand, giving that person permission to do so. Anyone collecting certificates on behalf of someone else must bring photographic identification. The signed record of certificates issued will be kept for a period of 12 months.

### **Candidates**

 May arrange for certificates to be collected on their behalf by providing the exams officer with written or email permission/authorisation; authorised persons must provide ID evidence on collection of certificates

# **Retention of Certificates policy**

The Exams Officer will contact wherever possible students whose certificates have not been collected after 12 months. If still not collected the Exams Officer will destroy by shredding any unclaimed certificates. A record of all certificates destroyed by the centre will be kept for a period of four years from the date of their destruction.

### Exams review: roles and responsibilities

### **Exams officer**

- Will provides SLT with an overview of the exam year, highlighting what went well and what could be improved in terms of exams management and administrative processes within the exam cycle
- Collects and evaluates feedback from staff, candidates and invigilators to inform an exams review

### **Senior leaders**

 Will work with the Exams Officer to produce a plan to action any required improvements identified in the review

### Retention of records: roles and responsibilities

### **Exams officer**

- Keeps records as required by JCQ and awarding bodies for the required period
- Keeps records as required by the centre's records management policy
- Provides an exams archiving policy that identifies information held, retention period and method of disposal

### **Exams archiving policy**

- Any hard copy information relating to an access arrangement candidate to be returned to SENCo as records owner at the end of the candidate's final exam series
- Attendance registers, seating plans and invigilation documents to be retained until the deadline for reviews of marking and any appeal, malpractice or results enquiry has been completed. Method of disposal: Shredding
- Any hard copies of non-examination assessment work to be logged on return to the centre and returned to subject staff
- Candidates Certificates: see Retention of Certificates policy
- Movement and Storage logs: Logs recording the receipt, movement and secure storage of exam materials, including where materials are issued securely to an authorised member of staff and dispatch logs, to be retained until the deadline for reviews of marking and any appeal, malpractice or results enquiry has been completed. Method of disposal: Shredding
- Question papers for timetabled written exams to be retained securely on the day of the examination and released to teaching staff the following day.
- Exam stationery to be stored in the secure storage facility between exams. Any surplus or out of date stationery to be shredded.
- Invigilator training and training for those facilitating an access arrangement to be retained on file until the deadline for reviews of marking and any appeal, malpractice or results enquiry has been completed. Method of disposal: Shredding

- JCQ publications and hard copy information from awarding bodies to be retained until the next academic year update is provided.
- Records for post results services and candidate consent forms must be retained for at least six months following the outcome of the clerical re-check, review of marking or any subsequent appeal (including Access to Scripts). Method of disposal: Shredding
- Results Information: records must be kept for the current year plus the previous 6 years as a minimum. Method of disposal: Shredding
- Special consideration documents: any evidence supporting an application for special consideration must be retained until after the publication of results. Method of disposal: Shredding
- Suspected malpractice reports to be retained until the deadline for reviews of marking and any appeal, malpractice or results enquiry has been completed. Method of disposal: Shredding
